Motion to accept minutes from prior meeting – June, 22 2012, made and seconded, and accepted.

Meeting was open to public participation.

Comments from Marge Golub ( as read by Dawn Dillon ) regarding signs

Jean Afzali presented a treasurer's report, which was accepted by members.

Alice Baker made a motion to authorize the Meeting Chair (Dawn Dillon ) to be able to purchase supplies etc. as necessary under \$ 50.00 without first asking the Board's permission. This was seconded by Cheryl Damiano, and approved.

- Communications from the Chair regarding parking tickets from July, 3 2012. Dawn collected tickets and brought them to Capt. Rogers. These tickets were forgiven. If anyone else has an outstanding ticket, they must follow the proper appeals process as documented on the ticket.

- We are on the Aug, 23 2012 MVSC agenda to discuss our resident parking proposal. Randy Parker was supposed to be present to provide input. We will go forward with signatures with the goal of getting on the Spring '13 town ballot .
- Dawn reviewed the public/private beach areas in response to a question from a member and public access points from Taylor Ave. Members are encouraged to attend the Aug, 23 MVSC meeting held at the Manomet Public Library 7pm .
- Jonathan Beder, DPW Director, came down to look at the Taylor Ave lot, after Dawn contacted him regarding the asphalt repairs that are necessary. It is on their agenda to pave the lot.
- Sign committee presentation by Alice Baker. Samples of **private way signs, dog signs & trash signs** were presented. Les Pike made the motion to vote on a sign choice. The association chose the blue dog sign, option A for public access, & green for the trash sign. A recommendation was made to change the **public beach sign**. It will be made larger and contain only the words public beach with an arrow. This motion was approved by members present. Signs will be ordered. Dawn reminded that property owners' permission MUST be obtained prior to placing signs. Tim Feely has offered to install signs.
- Old business – Viridien will be tabled till we are able to clarify our Non-profit status .
